- TCCW is revised to include the deletion of the stop/go manual and replacement with the portable traffic lights as a traffic control device.
- TCC for workers is based on the LTA Code of Practice for Traffic Control at work zone, and is designed for workers or anyone deployed to carryout roadworks in LTA projects.
- Under LTA CP requirements, only trained & competent persons are allowed to be involved in roadworks / traffic control where they must be conversant in the safe methods of placing, operating, maintaining and removing devices on the road

Learning Outcome:

- This course will cover effective planning and management of traffic control at work-zone and public safety.
- At the end of the course participants will have the basic skills and knowledge of managing traffic control and road safety.
